We would like to have all registration information, for this session, by September 3, 2021.

When calculating your dues, please remember to subtract \$1 for each hour you volunteered for DOTC during the last "school year". While this is on an honor system, we do ask that you briefly describe how you arrived at your total hours volunteered. If you were an instructor, we ask that you count 1 hour for each night you were teaching and add in "planning/set-up" time. If you assisted with a class, count only the time at class. Remember, we had the Obedience/Rally trials with set up, stewarding, and other workers. We had 6 days of FastCAT with an extra day of set-up. There are probably other ways that you volunteered for DOTC. Due to COVID, this past year, we did not have any community events. Maybe, this year, or next, we can add back in some community events! Hopefully, you kept notes of your volunteer hours for this past year. If you did not, use your memory, as best you remember. Be sure to keep a record for this upcoming year, so next year, it will be easier for you to remember how many volunteer hours you had! We could not do what we do without our marvelous volunteers!
