## Important "Covid-19" Trial Info



Please read!

### We want you to know what to expect before entering.

- As of the publishing of this premium, we expect the trial to go on as described. All trial decisions will be in accordance with Maryland state and local guidelines in place at the time of the trial.
- **Closing Date: Wednesday, March 2, 2022.**
- In the event that the trial needs to be canceled because of virus restrictions, we will make every attempt to make a decision **no later than the closing date** (100% refund-checks will not be cashed). If circumstances cause us to cancel after closing, DOTC will refund all but \$10 of each entry fee for administrative costs. All other refunds after closing are as detailed in the refund section.
- Dog Owners' Training Club is making every effort to supply a safe trial environment. However, exhibitors are entering the trial at their own risk.

### Other things you can expect on trial days:

- **MOST IMPORTANT:** If you are exhibiting signs of illness, have tested positive or have been otherwise told to self-quarantine due to known Covid-19 exposure, please stay home.
- **Indoor crating will be allowed. 10 x 10 areas will be marked out on the floor for "social distanced" crating.** The building is large enough to maintain social distancing.
- **Masks:** As of the publishing of this premium, a properly worn face mask (covering both nose and mouth) may be required at all times in the building.
- The Covid-19 protocols are constantly changing. We will follow state, local and facility guidelines at the time of the event. Updated information will be published in the judging schedule and/or posted at the site.
- Social distancing guidelines are still to be followed with people outside your immediate family and/or known social circle. This includes interactions with judges, volunteers and host club members.
- **CHECK-IN:** The check-in and armband pick-up area will be clearly marked. A covid waiver will not be required this year.
- Paper course maps will not be available. Course maps will be displayed in several places. Come prepared to photograph the map for your personal use.
- Food will not be available onsite. Plan on bringing your own lunch, water, drinks, ice, etc.
- Briefings/walkthroughs: Expect distance briefings, smaller walkthroughs.
- Event attendees voluntarily assume all risk related to exposure to communicable diseases.
- Exhibitors are expected to follow state, local government, event and facility guidelines. Full details will be included in the judging schedule.

Please include legible e-mail address on your entry form.  
Do not send entries requiring a signature upon delivery.  
Entries **MUST** include "A" or "B" and/or jump height (if applicable) in order to be processed.

Exhibitors providing email addresses will receive all communication, including confirmation and judging schedule through email.

Telegraph, telephone and unsigned entries cannot be accepted. Entries not on an official AKC entry form and photocopies of entry forms without agreement and rules section of the official AKC entry form are NOT ACCEPTABLE. Owners are responsible for errors in entry forms, regardless of who may make such errors. (AKC Rules Applying to Dog Shows, Chapter 11, Section 6.) No entry fee will be refunded in event of such errors or cancellation of entries after the published closing date.

Entries received without fees will not be accepted. Returned checks, post-dated checks or declined credit cards do not constitute a valid entry fee. The Show Secretary will add a \$30 collection fee to the amount of each returned check. Entry fees will not be refunded in the event that a dog is absent, disqualified, or excused by the Judge or Veterinarian, or barred from competition by action of the Show Committee. If because of riots, civil disturbances, or other acts beyond the control of the show giving club, it is impossible to open or complete the show, no refunds will be made. An AKC Recording Fee of \$.50 first entry only and an AKC Event Service Fee of \$3.00 per entry will be required for each dog entered at any Licensed or Member Club Show, Obedience Trial or Tracking Test. An AKC Recording Fee of \$3.50 will be required for each first entry, \$3.00 for each additional entry in any Licensed or Member Club Rally Trial. All Recording and Event Service Fees are paid to the American Kennel Club. (Rules Applying to Dog Shows, Chapter 11, Section 2)

*If you use an entry service (superintendent, online entry or fax service) other than the Show Secretary listed in the premium, please be aware of their terms, additional charges and delivery policies.*

*Entries are processed in the order that they are received at the address of the Show Secretary.*

## Notice to Exhibitors

- All judging will be indoors.
- Transfers will be permitted in accordance with Obedience Regulations, Chapter 1, Section 16 and Rally Regulations, Chapter 1, Section 15. The request for a transfer must be in writing and presented to the Trial Secretary at least 30 minutes prior to the start of the trial.
- The Rally rings are 40 x 50 feet. The two rally trials will run **concurrently**. Start times are likely to be offset to help avoid conflicts.
- A wait-list will be established in order to fill openings created by entries that are withdrawn prior to the event closing day. Exhibitors who wish a UDX/RAE/RACH entry should check the box on the entry form. If all waitlisted classes do not become available by closing, the multiple-class entries will be returned and the next eligible waitlisted person will receive an available slot.
- Obedience and Rally classes will run in jump height order from "Tall-Small." Your jump height must be included on the entry form for all classes that require a jump.
- Food will **not** be available at the show site. Fast food is available within 2 miles.
- Free admission / Free parking. There is plenty of parking available.
- **REFUND POLICY:**  
Bitches in season are not permitted to compete in obedience trials. The club will refund all but \$10.00 of the entry fee for bitches in season that are unable to compete for that reason. Refund requests must be accompanied by a dated, signed letter on official business letterhead from your veterinarian stating the reason that your dog cannot compete. The Trial Secretary must be notified no later than one half hour prior to the start of the first class in the trial. E-mails, phone calls and non-letterhead notes will not be considered.
- Exhibitors are responsible for cleaning up after their dog(s). Any exhibitor failing to do so may be excused without benefit of refund if the Show Committee deems the exhibitor to be in violation of this requirement. No dogs under 4 months of age on show grounds. There will be no smoking in the building. Please dispose of all trash in the proper manner.
- The judge is not required to wait for dogs. It is the responsibility of the owner/handler to have the dog at ringside when required and without being called. All dogs present must be held on a leash, or confined to a crate except when being judged.
- Exhibitors should follow their veterinarians recommendation to assure their dogs are free of internal and external parasites, any communicable diseases, and have appropriate vaccinations
- It is expressly understood that exhibitors alone are responsible for the behavior of their dogs and/or children. Any exhibitor whose dogs and/or children create unnecessary disturbances or repeatedly engage in unsafe or disruptive behavior may, at the discretion of the Event Committee, be asked to leave the show site. In such case, no refund of any fees paid will be made.
- **Notice—Waiver of Rights:** The host club, Clantyre Show Secretary Services, Carroll County Agriculture Center, their agents, employees, etc. will assume no responsibility for any loss, damage, illness or injury sustained by exhibitors or handlers, or to any of their dogs or property and further assumes no responsibility for injury to children.
- A limited number of catalogs will be available for sale at the show site for \$5.00.

## Directions to the Trial Site

From the North, East, or South:

Follow I-695 (Baltimore Beltway) to Exit 19 (I-795) towards Owings Mills/Reisterstown continuing until the expressway ends. Bear right onto Route 140 West (towards Westminster) continuing for 10.9 miles to the light at Center Street. Turn left at the light onto Center Street. Proceed 1.6 miles through a four-way stop sign and two traffic lights. Go past the Farm Museum on the right and Carroll Hospital on the left and you will be at the stop sign at Gist Road. Turn right onto Gist Road. Drive 0.1 miles and turn right onto Ag Center drive.

From the East or South - Alternate route (more back road driving):

Take Route 32 West (to Sykesville/Westminster). Turn left on Kate Wagner Road. Turn right onto Gist Road. After you pass Smith Ave turn left onto Ag Center drive.

From the West:

From I- 70 Exit 68 – Route 27 North to right onto Kate Wagner Rd. Turn left onto Gist Road and follow alternate route directions above.

From I-70 Exit 76 – Route 97 North to left on Hook Road. Turn right onto Gist Road and follow alternate route directions above.



- A dog must be entered in the name of the person who actually owned it at the time the entries for a show closed. If a registered dog has been acquired by a new owner it must be entered in the name of its new owner in any event for which entries closed after the date of the acquirement, regardless of whether the new owner has received the registration certificate indicating that the dog is recorded in his name. State on entry form whether transfer application has been mailed to A.K.C. (For complete rule refer to Chapter 11, Section 3).
