## NOTICE TO EXHIBITORS

**Assignment of order: 6 dogs at a time will be assigned a start time. Please inform us if you need to be scheduled with another exhibitor. Exhibitors may arrive up to 30 minutes prior to their assigned times and check in at the registration table. Do not bring any dogs to the Check-in table. Run order will be emailed prior to the day of the event.**

### **SAFETY, BEHAVIOR and LIABILITY**

The safety of the dog is our primary concern. By entering this test, exhibitors acknowledge that they are familiar with the rules and regulations of this sport, and that their dogs are familiar with and able to perform all stations safely. It is expressly understood that exhibitors alone are responsible for the behavior of their dogs and/or children. Any exhibitor whose dogs and/or children create an unnecessary disturbance or repeatedly engage in unsafe or disruptive behavior may, at the discretion of the test committee, be asked to leave the test site. In such a case, no refund of any fees paid will be made. The DOTC will assume no responsibility for any loss, damage or injury sustained by exhibitors or handlers, or to any of their dogs or property and further assumes no responsibility for injury to children. The DOTC reserves the right to decline entries for cause and may remove any dog on account of aggression. No one shall have any recourse or claim against the DOTC or any official thereof.

**Collars, Leashes and Harnesses:** During the Test, dogs must wear a properly fitted collar approved by the judge. Leashes may be of any length. The leash should be made of plain, pliable material. All dogs **must be on leash, or crated, at all times.** Retractable leashes may not be used when on test grounds. No prong or electronic collars are permitted.

**REFUNDS:** No entry fee will be refunded if the test cannot open or be completed by reason of riots, civil disturbances, fire, an act of God, public emergency, act of a public enemy, or any other cause beyond the control of the organizing committee. No entry fee will be refunded in the event a dog is absent, disqualified, excused, or barred from examination by the action of the Test Committee. Dogs pulled after closing because of injury or other medical condition are not eligible for a refund.

**Bitches in season** will be refunded the full entry fee. Notification in writing must be given to the trial secretary no later than the day of the trial.

Claims will be arbitrated as set forth on the Official AKC Entry Form for this event.
